1. Public comments.
2. Ratification of Emergency or Urgent Actions, if any, and ratification of COVID-19 epidemic related emergency actions, if any:
 - a. ratification of approval of Development Financing Agreement.
3. Approve minutes.
4. Financial and bookkeeping matters, including payment of the bills and review of investments.

 - g. discussion regarding delinquent accounts and terminations;
 - h. BBVA Compass Bank Treasury Agreement; and
 - i. Winter storm insurance claim.
10. Conduct annual review and receive report from operator on Identity Theft Prevention Program and adopt Identity Theft Prevention Program Amendment.

Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
