 - a. utility billings;

 - d. wastewater treatment plant repairs and maintenance;
 - e. grinder pump repairs;
 - f. remote deposits; and
 - g. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
6. Review Critical Load Spreadsheet for District's facilities and authorize annual filing.

Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
 - a. Capital Improvement Plan;
 - b. generator at water plant site;
 - c. backwash basin liner;
 - d. confirm filing of Emergency Preparedness Plan with the Texas Commission on Environmental Quality;
 - e. inspections and repairs;
 - f. zebra mussel removal and prevention, and barge maintenance;
 - g. contingency plan for District facilities;
 - h. requests for service or utility commitment letters; and
 - i. other engineering matters.
