TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 10

The Board of Directors of Travis County Municipal Utility District No. 10 will hold a regular meeting on **Tuesday, December 6, 2022, at 10:30 a.m.**, at **1845 Kingfisher Ridge Cove, Lago Vista, TX 78645***, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Financial and bookkeeping matters, including payment of the bills review of investments.
4. Tax assessment and collections matters, including delinquent tax collections, and payment of tax bills.
5. Operation of District facilities:
 - a. utility billings;
 - b. drought contingency status;
 - c. water treatment plant operation, repairs, and maintenance;
 - d. wastewater treatment plant repairs and maintenance;
 - e. grinder pump repairs;
 - f. remote deposits;
 - g. review of Waterford Marina lease;
 - h. garbage collection matters;
 - i. adopt Amended Rate Order; and
 - j. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.

Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
 - a. Capital Improvement Plan;
 - b. generator at water plant site;
 - c. backwash basin liner;
 - d. inspections and repairs;
 - e. zebra mussel removal and prevention, and barge maintenance;
 - f. requests for service or utility commitment letters;
 - g. hydrology study, including discussion of possible locations and summary of costs for additional water wells;
 - h. remediation of odor at lift station no. 1; and
 - i. other engineering matters.
7. Review and update Eminent Domain Report to the Texas Comptroller.

8. Travel Reimbursement Guidelines and Director Expenses for the Association of Water Board Directors winter conference.
9. Discuss Contingency Planning.
10. Adopt Resolution Establishing Additional Out-of-District Meeting Place.
11. Report regarding development in the District.
12. District and property owner associations coordination and Board member input regarding issues facing the district.
13. Report on the request for LCRA for approval of No Wake Zones in Lake Travis adjacent to the District, consider Permit from the LCRA regarding the No Wake Zones and a maintenance agreement with the Waterford on Lake Travis Section III Property Owners Association, and take any necessary action.

15. Newsletter, communications with residents and or property owners regarding updates to IRIS district communication system and other district communications.
