

## NOTICE OF MEETING

### TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 10

The Board of Directors of Travis County Municipal Utility District No. 10 will hold a regular meeting on **Tuesday, May 2, 2023, at 10:30 a.m.**, at **1845 Kingfisher Ridge Cove, Lago Vista, TX 78645\***, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Financial and bookkeeping matters, including payment of the bills review of investments.
4. Travel Reimbursement Guidelines and Director Expenses for the Association of Water Board Directors summer conference.
5. Tax assessment and collections matters, including delinquent tax collections, and payment of tax bills.
6. Operation of District facilities:
  - a. utility billings;
  - b. drought contingency status;
  - c. water treatment plant operation, repairs, and maintenance;
  - d. wastewater treatment plant repairs and maintenance;
  - e. grinder pump repairs;
  - f. remote deposits;
  - g. garbage collection matters; and
  - h. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
7. Approve Consumer Confidence Report and authorize operator to deliver Consumer Confidence Report and file certificate of delivery with the Texas Commission on Environmental Quality.
8. Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
  - a. Capital Improvement Plan;
  - b. generator at water plant site;
  - c. backwash basin liner;
  - d. inspections and repairs;
  - e. zebra mussel removal and prevention, and barge maintenance;
  - f. requests for service or utility commitment letters;
  - g. emergency water well project;

- h. adopt Order Establishing Rules and Regulations Regarding Sanitary and Pollution Control of the Areas in Proximity to the District's Public Water Supply Well;
  - i. remediation of odor at lift station no. 1; and
  - j. other engineering matters.
9. Adopt Amended and Restated Resolution Establishing Addresses and Methods for Texas Public Information Act Requests and Authorize publishing notice of the change on District website(s).
  10. Adopt Amended and Restated Resolution Designating Agent for Issuance of Notice to Purchasers.
  11. Adopt Resolution Changing District Offices.
  12. Report regarding development in the District.
  13. District and property owner associations coordination and Board member input regarding issues facing the district.
  14. Report on the request for LCRA for approval of No Wake Zones in Lake Travis adjacent to the District, consider Permit from the LCRA regarding the No Wake Zones and a maintenance agreement with the Waterford on Lake Travis Section III Property Owners Association, and take any necessary action.
  15. Report on the District website.
  16. Newsletter, communications with residents and or property owners regarding updates to IRIS district communication system and other district communications.
  17. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney, and discuss pending or contemplated litigation, or a settlement offer.
  18. Reconvene in Open Session and authorize appropriate action regarding matters considered in Executive Session, or a settlement offer.
