

NOTICE OF MEETING

TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 10

The Board of Directors of Travis County Municipal Utility District No. 10 will hold a regular meeting on **Tuesday, August 1, 2023, at 10:30 a.m.**, at **18001 Kingfisher Ridge Dr., Lago Vista, TX 78645***, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Financial and bookkeeping matters, including payment of the bills review of investments.
4. Tax assessment and collections matters, including delinquent tax collections, and payment of tax bills.
5. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.
6. Discuss 2023 tax rate, set public hearing date, and authorize notice of public hearing regarding adoption of tax rate.
7. Approve annual report and authorize filing of same in accordance with District's Continuing Disclosure of Information Agreement and as required by SEC rule 15c2-12.
8. Annual Review of Procedures for Continuing Disclosure Compliance.
9. Operation of District facilities:
 - a. utility billings;
 - b. drought contingency status;
 - c. water treatment plant operation, repairs, and maintenance;
 - d. wastewater treatment plant repairs and maintenance;
 - e. grinder pump repairs;
 - f. remote deposits;
 - g. garbage collection matters; and
 - h. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
10. Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
 - a. Capital Improvement Plan;
 - b. generator at water plant site;
 - c. inspections and repairs;
 - d. zebra mussel removal and prevention, and barge maintenance;
 - e. requests for service or utility commitment letters;
 - f. emergency water well project;

- g. remediation of odor at lift station no. 1; and
- h. other engineering matters.
- 11. Discuss contingency planning.
- 12. Discuss coordination between the the Lower Colorado River Authority (LCRA) and the District regarding Lake Travis water levels.
- 13. 2023 Legislative update on property taxes and related matters.
- 14. Report regarding development in the District.
- 15. District and property owner associations coordination and Board member input regarding issues facing the district.
- 16. Report on the District website.
- 17. Newsletter, communications with residents and or property owners regarding updates to IRIS district communication system and other district communications.
- 18. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney, and discuss pending or contemplated litigation, or a settlement offer.
