

NOTICE OF MEETING

TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 10

The Board of Directors of Travis County Municipal Utility District No. 10 will hold a regular meeting on **Tuesday, September 5, 2023, at 10:30 a.m.**, at **17805 Kingfisher Ridge Cove, Lago Vista, TX 78645***, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Financial and bookkeeping matters, including payment of the bills review of investments.
4. Tax assessment and collections matters, including delinquent tax collections, and payment of tax bills.
5. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.
6. Conduct public hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form.
7. Conduct annual review of Investment Policy and adopt Resolution Regarding Annual Review of Investment Policy.
8. Review, revise, and adopt Resolution Establishing the Authorize Depository Institutions and Adopting List of Qualified Broker/Dealers with Whom the District May Engage in Investment Transactions.
9. Receive report regarding proposed site visit by Burns & McDonald on behalf of Megalland Midstream Partners and Non-disclosure Agreement, and take any necessary action.
10. Emergency bulk water supply to Travis County Water Control and Improvement District - Point Venture, and take any necessary action.
11. Operation of District facilities:
 - a. utility billings;
 - b. drought contingency status;
 - c. water treatment plant operation, repairs, and maintenance;
 - d. wastewater treatment plant repairs and maintenance;
 - e. grinder pump repairs;
 - f. remote deposits;
 - g. garbage collection matters; and
 - h. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
12. Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
 - a. Capital Improvement Plan;

- b. generator at water plant site;
 - c. inspections and repairs;
 - d. zebra mussel removal and prevention, and barge maintenance;
 - e. requests for service or utility commitment letters;
 - f. emergency water well project;
 - g. remediation of odor at lift station no. 1; and
 - h. other engineering matters.
13. Report regarding development in the District.
 14. District and property owner associations coordination and Board member input regarding issues facing the district.
 15. Report on the District website.
 16. Newsletter, communications with residents and or property owners regarding updates to IRIS district communication system and other district communications.
 17. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney, and discuss pending or contemplated litigation, or a settlement offer.
 18. Reconvene in Open Session and authorize appropriate action regarding matters considered in Executive Session, or a settlement offer.
 19. Next meeting date (Tuesday, October 3, 2023).
