### TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 10


The Board of Directors of Travis County Municipal Utility District No. 10 will hold a regular meeting on **Tuesday, October 1, 2024, at 10:30 a.m.**, at **17805 Kingfisher Ridge Drive, Lago Vista, Texas 78645\***, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
  - a. Capital Improvement Plan and related expenditures;
  - b. generator at water plant site;
  - c. report on emergency water well project, and take any necessary action;
  - d. inspections and repairs;
  - e. zebra mussel removal and prevention and barge maintenance;
  - f. requests for service or utility commitment letters, including service availability request and related matters for 1616 Watercliffe;
  - g. report on Lake Travis water levels and consider modifications to barge to access lower lake levels, and take any necessary action;
  - h. post-construction review of construction projects; and
  - i. other engineering matters.
4. Consider acquisition of pre-owned or new generator and take any action necessary.
5. Discuss facilities security, storage area adjacent to District water plant and fire protection.
6. Operation of District facilities, including:
  - a. utility billings;
  - b. drought contingency status;
  - c. water treatment plant operation, repairs, and maintenance;
  - d. wastewater treatment plant repairs and maintenance;
  - e. grinder pump repairs;
  - f. remote deposits;
  - g. garbage collection matters;
  - h. hearing on termination of water and sewer service to delinquent customers and authorize termination of service;

- i. ratify approval of bid for relocation of waterline on Osprey Ridge Loop; and
  - j. discuss Pro Rata Curtailment Plan and take any necessary action.
7. Financial and bookkeeping matters, including payment of the bills, review of investments, and review annual budget in revised format.
8. Tax assessment and collections matters, including delinquent tax collections, and payment of tax bills.
9. Report regarding development in the District.
10. Report on District and property owner associations coordination and Board member input regarding issues facing the District.
11. Report on the District website.
12. Newsletter, communications with residents and or property owners regarding updates to IRIS district communication system and other District communications.
13. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney, and discuss pending or contemplated litigation, or a settlement offer.
14. Reconvene in Open Session and authorize appropriate action regarding matters considered in Executive Session, or a settlement offer.
