### TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 10


The Board of Directors of Travis County Municipal Utility District No. 10 will hold a regular meeting on **Tuesday, August 5, 2025, at 10:30 a.m., at 1316 Watercliffe Drive, Texas 78645\***, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve Minutes.
3. Discuss 2025 tax rate, set public hearing date, and authorize notice of public hearing regarding adoption of tax rate.
4. Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
  - a. report on Capital Improvement Plan and related expenditures;
  - b. report on Emergency Preparedness Plan; and
  - c. other engineering matters.
5. Operation of District facilities, including:
  - a. utility billings;
  - b. drought contingency status;
  - c. water treatment plant operation, repairs, and maintenance;
  - d. wastewater treatment plant repairs and maintenance;
  - e. grinder pump repairs;
  - f. remote deposits;
  - g. garbage collection matters;
  - h. hearing on termination of water and sewer service to delinquent customers and authorize termination of service; and
  - i. approve the contract renewal form Si Environmental, LLC.
6. Discuss agreement with Si Environmental, and take any necessary action.
7. Financial and bookkeeping matters, including payment of the bills, review of investments, and review annual budget in revised format.
8. Approve annual report and authorize filing of same in accordance with District's Continuing Disclosure of Information Agreement and as required by SEC rule 15c2-12.
9. Annual Review of Procedures for Continuing Disclosure Compliance.
10. Authorize renewal of District's insurance policies, including review of engineer's list of District facilities to be insured.
11. Tax assessment and collections matters, including delinquent tax collections, and payment of tax bills.

17. Reconvene in Open Session and authorize appropriate action regarding matters considered in Executive Session, or a settlement offer.
