TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 10


The Board of Directors of Travis County Municipal Utility District No. 10 will hold a regular meeting on **Tuesday, October 7, 2025, at 10:30 a.m., at 1100 Watercliffe Drive, Lago Vista, Texas 78645***, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve Minutes.
3. Ratification of emergency or urgent actions, if any.
4. Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
 - a. review and consider proposal no. 250155 for the Re-Rate Study for the WWTP;
 - b. report on Water and Wastewater Treatment Capacity;
 - c. report on updates to Capital Improvement Plan and related expenditures;
 - d. report on and propose a solution for internal piping/backwash overflow;
 - e. report on and propose a solution for the additional fuel storage required for the generator;
 - f. consider proposal for a hydrogeologist for wells;
 - g. request for service availability letter; and
 - h. other engineering matters.
5. Operation of District facilities, including:
 - a. utility billings;
 - b. drought contingency status;
 - c. water treatment plant operation, repairs, and maintenance;
 - d. wastewater treatment plant repairs and maintenance;
 - e. grinder pump repairs;
 - f. remote deposits;
 - g. garbage collection matters;
 - h. hearing on termination of water and sewer service to delinquent customers and authorize termination of service; and
 - i. discuss request from resident related to damage due to water leak.
6. Financial and bookkeeping matters, including payment of the bills, and review of investments.

11. Newsletter, communications with residents and or property owners regarding updates to IRIS district communication system and other District communications.
12. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney, and discuss pending or contemplated litigation, or a settlement offer.
13. Reconvene in Open Session and authorize appropriate action regarding matters considered in Executive Session, or a settlement offer.
