### TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 10

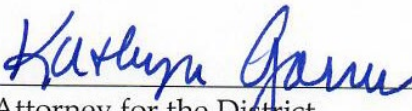
The Board of Directors of Travis County Municipal Utility District No. 10 will hold a regular meeting on **Monday, November 10, 2025, at 10:30 a.m., at 1316 Watercliffe Drive, Lago Vista, Texas 78645\***, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve Minutes.
3. Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
  - a. report on request for service availability letter;
  - b. report on status of construction of alum fee piping;
  - c. report on status of construction of internal piping/backwash overflow;
  - d. discuss and consider proposal for a hydrogeologist for wells;
  - e. report on status of re-rate study and analysis of data;
  - f. report on updates to Capital Improvement Plan and related expenditures;
  - g. report on update to Emergency Preparedness Plan; and
  - h. other engineering matters.
4. Operation of District facilities, including:
  - a. utility billings;
  - b. drought contingency status;
  - c. water treatment plant operation, repairs, and maintenance;
  - d. wastewater treatment plant repairs and maintenance;
  - e. grinder pump repairs;
  - f. remote deposits;
  - g. garbage collection matters;
  - h. hearing on termination of water and sewer service to delinquent customers and authorize termination of service; and
  - i. discuss request from resident related to damage due to water leak.
5. Financial and bookkeeping matters, including payment of the bills, and review of investments.
6. Review Final Arbitrage Rebate Report for the Series 2011 Bonds.
7. Tax assessment and collections matters, including delinquent tax collections, payment of tax bills, and proposed settlement of delinquent taxes.
