TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 10


The Board of Directors of Travis County Municipal Utility District No. 10 will hold a regular meeting on Tuesday, April 7, 2026, at 10:30 a.m., at 1845 Kingfisher Ridge Cove, Lago Vista, Texas*, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve Minutes.
3. Ratification of emergency or urgent actions, if any.
4. Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
 - a. update on backwash pond pump analysis;
 - b. update on water well planning including discussion on Lower Trinity Well;
 - c. review and approval of Apex Drilling proposal for 36-Hour Pump Test;
 - d. review and approval of BBA proposal for analysis of 36-Hour Pump Test;
 - e. update regarding Waterford 4B and 2A development status; and
 - f. other engineering matters.
5. Operation of District facilities, including:
 - a. utility billings;
 - b. drought contingency status;
 - c. water treatment plant operation, repairs, and maintenance;
 - d. wastewater treatment plant repairs and maintenance;
 - e. grinder pump repairs;
 - f. remote deposits;
 - g. garbage collection matters; and
 - h. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
6. Financial and bookkeeping matters, including payment of the bills, and review of investments.
7. Discuss Request for Qualifications for Bookkeeping Services, and take any necessary action.
8. Conduct annual review and receive report from operator on Identity Theft Prevention Program and adopt Identity Theft Prevention Program Amendment.
9. Tax assessment and collections matters, including delinquent tax collections, payment of tax bills, and proposed settlement of delinquent taxes.
