

NOTICE OF MEETING

TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 10

The Board of Directors of Travis County Municipal Utility District No. 10 will hold a regular meeting on Tuesday, June 2, 2026, at 10:30 a.m., at 1316 Watercliffe Drive, Lago Vista, Texas*, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve Minutes.
3. Ratification of emergency or urgent actions, if any.
4. Engineering matters, including authorize design, approve plans and specifications and authorize advertisement for bids, review bids and award contracts, approve pay estimates, change orders, and final acceptance, direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including:
 - a. update on backwash pond pump analysis, including any proposals;
 - b. update on water well planning, including report from BBA;
 - c. update regarding Waterford 4B and 2A development status; and
 - d. other engineering matters.
5. Approve Risk and Resilience Assessment and filing of certification of same with with Environmental Protection Agency.
6. Operation of District facilities, including:
 - a. utility billings;
 - b. drought contingency status;
 - c. water treatment plant operation, repairs, and maintenance;
 - d. wastewater treatment plant repairs and maintenance;
 - e. grinder pump repairs;
 - f. remote deposits;
 - g. garbage collection matters; and
 - h. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
7. Approve Consumer Confidence Report and authorize operator to deliver Consumer Confidence Report and file certificate of delivery with the Texas Commission on Environmental Quality.
8. Financial and bookkeeping matters, including payment of the bills, and review of investments.
9. Terminate Bookkeeping Services Agreement with Myrtle Cruz, Inc., and Engage Municipal Accounts & Consulting, L.P. as the District's Bookkeeper.
10. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.


